⁴ If the aggregated partial prepayment amount in the first 2 years from drawdown exceeds 90% of the original loan amount, the full prepayment charge shall apply. The minimum partial prepayment is MOP/HKD50,000 per payment transaction.

The finance charge will accrue daily and be calculate at the annual rate of 28.8%.
